1. The Export Processing Zones Authority has set aside funds and intends to apply part of the proceeds to cover eligible payments under the contract for Construction of Industrial buildings at Benjamin William Mkapa Special Economic Zone (BWM-SEZ).
2. The Export Processing Zones Authority intends to pre-qualify Local Building Contractors and/or firms registered by Contractors Registration Board in **Class II and above** category for Construction of the industrial buildings stated above. It is expected that invitations to bid will be made in June, 2011.
3. Pre-qualification will be conducted through the procedures specified in Regulation 15 of the Public Procurement (Goods, Works, Non-Consultant Services and Disposal of Public Assets by Tender) Regulations, 2005 – Government Notice 97 of 15<sup>th</sup> April 2005, and is open to all eligible firms and voluntarily formed joint ventures.
4. Interested Contractors may obtain further information and inspect the prequalification documents at the Export Processing Zones Authority (address below) from 8.00 am to 03.30pm Mondays to Fridays excluding holidays.
5. A complete set of prequalification documents in English may be purchased by interested applicants and voluntarily formed joint ventures on the submission of a written application to the address below and upon payment of a nonrefundable fee of **Tanzania Shillings One Hundred Thousand Only (T.shs 100,000)**. The method of payment will be cash, bank draft or banker's cheque to Export Processing Zones Authority
